*'New Patent Will Significantly Expand And Extend Ameranth's Vast Patent Portfolio'*

*September 26, 2023, San Diego, CA* — Ameranth, Inc. announced today that it has just been issued a new 'AI Based' strategic patent #**11,770, 304** by the USPTO. This entirely new patent will expand vastly beyond Ameranth's already very extensive, existing portfolio of **8** issued and **3** pending patents and the new '**304 patent** will serve as a platform to integrate, multi-faceted, AI based systems/solutions for an entire 'second generation' of Ameranth pioneering innovations, systems and patents ---and for many years to come.

The new '**304 Patent** is titled '**An Adaptable Computing Network With Real Time, Intelligent, 4D Spherical Scalability, Tech Stack Awareness, Tech Stack Integration, Automatic Bi-Directional Communications Channel Switching And Order Equilibrium - For Large Enterprise, Time Sensitive Event/Transaction Driven Applications**'. It includes **30** new claims (conceived by Ameranth's Founder/President and lead inventor, Keith McNally) - which are initially claimed in respect to **4** Hospitality Market Embodiments, of **(1)** food/drink ordering, **(2)** restaurant reservations, **(3)** hotel/rental reservations, and **(4)** event ticketing; (but also includes poker/gaming solutions too) and its scope is far broader than these initial embodiments. Figure 1 below provides a general visualization of some of its new revelatory inventive concepts/integrations and unique/'non conventional' ordered combinations.

That these new technological advancements and innovations are visionary and entirely new was/is confirmed by the USPTO Examiner in the '**304 patent** 'Notice of Allowance' reasons:

*"The prior art of record fails to teach neither singly nor in combination, the claimed limitations of claim 1 (and similarly in claims 2-4). These limitations, in conjunction with other limitations in the independent claim, are not specifically disclosed or remotely suggested in the prior art of record. A review of claims 1-30 indicated that claims 1-30 are allowable over the prior art of record."*
